Staff: Rand explained the State of Minnesota requires a different signatory line and this resolution would make that amendment.

3. RESOLUTION 18D-07: RESOLUTION AUTHORIZING ADDENDUM TO THE DEDA CONTRACT NO .17 860 858 WITH SUPERIOR INDUSTRIAL LLC AUTHORIZING REIMBURSEMENT OF \$105,000 FOR REMEDIATION

Staff: Rand explained this provides for lower sale price of the property, but placing the funds in an escrow account so those funds are available to use for soil corrective work if need be. Timm-Bijold added that most properties the commission deals with have some sort of remedial work and these funds will be available should the need arise. Commissioners expressed concern about lowering the price of the land and setting a precedent. Asleson said the buyer did not conduct sufficient soil investigation in this case prior to sale, and the purchase agreement allowed for a certain amount of time for due diligence and the purchaser exercised that option to renegotiate sale price as proposed.

4. RESOLUTION 18D-08: RESOLUTION AUTHORIZING AN EXTENTION OF THE AIRPORT GROUND LEASE AND AGREEMENT WITH THE DULUTH AIRPORT AUTHORITY REGARDING CERTAIN PROPERTY AT THE DULUTH INTERNATIONAL AIRPORT

Staff: Rand explained that this resolution is to ensure Cirrus can continue to use their facility. Rand reported on the employment statistics of Cirrus and their business continues to exceed expectations in terms of employment opportunities and sales.

Discussion: Norr asked if the terms of this agreement remain the same and Christensen answered that they do.
