## Hotel/Motel Tax Collections

The monthly prior year variance for hotel/motel tax collections was down significantly, and the year-to-date comparison was down slightly. There were deliquent returns filed in the prior year and a large delinquent return in the current year. If the returns were filed timely, the

month-to-month variance would be down slightly.
