Subject: Police looking for Non Compliant Predatory Offenders

The Duluth Police Department is looking for the public's help in finding seven convicted predatory offenders who have not been complying with registration requirements. Police have been trying to find the seven with no success. State law requires certain offenders to register their address and give authorities other information. The seven are:



James Evan Akin

Description: 42 year old white male, 6 feet 1, 220 pounds, brown/gray hair, blue eyes

Last known address for Akin: Area of 24th Avenue West and 4th Street in 2008

Due to being non compliant with registration requirements, there is currently a felony no bail warrant on Akin for Violation of Predatory Offender Registration Provisions



Donald Arthur Zawchenuk

Description: 48 year old white male, 5 feet 8, 200 pounds, blond hair, blue eyes

Last known address for Zawchenuk: Area of Mesaba Avenue and First Street

Besides being non compliant with registration requirements, there is currently a felony no bail warrant on Zawchenuk for Theft.



Frank Charles Morrisseau

Description: 37 year old Native American male, 5 feet 10, 185 pounds, black hair, brown eyes

Last known address for Morrisseau: Area of 15th Avenue East and Superior Street in 2008.

Due to being non compliant with registration requirements, there is currently a felony no bail warrant on Morrisseau for Violation of Predatory Offender Registration Provisions.



Michael Laray Winding

Description: 40 year old black male, 6 feet, 300 pounds, black hair, brown eyes

Last known address for Winding: Area of First Avenue West and Second Street

Besides being non compliant with registration requirements, there is currently a felony no bail warrant on Winding for a Controlled Substance Crime in Anoka County.



Charles Edward Meads Jr

Description: 37 year old black male, 6 feet 1, 195 pounds, black hair, brown eyes

Last known address for Meads: Area of 2nd Avenue East and First Street

Meads only violation/want at this time is for being non compliant with registration requirements

Moen's only violation/want at this time is for being non compliant with registration requirements
